

Arunachal Pradesh Rural Bank (APRB) invites application on plain paper with full bio-data from eligible retired Scale-III to Scale-IV officers of Public Sector Banks / Regional Rural Banks for a post of External Concurrent Auditor of APRB on contract basis.

Terms of appointment for retired officers have been given below :

- i) Officials retired from Scale-III to Scale-IV from RRBs or Public Sector Banks.
- ii). There should not be any gap of more than two years from the date of retirement at the time of engaging the officer.
- iii). The period of engagement of these ex- officials will be for a period of two years subject to annual review and renewal of engagement. However, the engagement of an ex-official will be terminated if he/she attains 65 years of age during the period of engagement. The engagement may be terminated at any time by giving 30 days notice on non-performance.
- iv). The applicant should be well experienced in operation and preferably be from audit background.
- v). 15 days leave will be allowed for every financial year of engagement or on pro-rata basis or part thereof. Accumulation of leave will be up to maximum 6 days. Carrying forward of leaves to next financial year or encashment will not be permitted.
- vi). HRA or lease of rent will not be paid.
- vii). Conveyance allowances/Travelling Allowances & HA will be paid to the Concurrent Auditor (CA) as per the eligibility of his/her Scale in the bank.
- viii). Remuneration of the Concurrent Auditor has been fixed as under :
 - a). For Scale-III Rs.35000/- (all inclusive)
 - b). For Scale-IV Rs.42000/- (all inclusive)

The retired officer's appointment will be based on a selection process to be approved by Audit Committee of the Board of APRB.
